Miriam Rea, Jennifer Romero and Nicole Saunders. See our website for new staff bios, and read on in this Annual Report for more about Grace's new position.



## GRACE SPULAK & **FosterEd: New Mexico**

*Former Pegasus staff attorney, Grace Spulak, is now directing the FosterEd: New Mexico initiative aimed at improving education outcomes for young people in the child welfare and juvenile justice systems. FosterEd, an initiative of the National Center for Youth Law, based in Oakland, California, was invited to work in New Mexico by the New Mexico Supreme Court and CYFD through their Joint Education Task Force. FosterEd currently runs a demonstration project in Lea County through which an education liaison works directly with students and families to ensure that the student's education needs are being met, and that, in general, education is treated as a priority for young people in the child welfare and juvenile justice systems. FosterEd is also working with stakeholders to expand FosterEd statewide, and implement the new federal Every Student Succeeds Act, which contains specific protections for young people in foster care and the juvenile justice system. Grace will be co-locating at Pegasus. We look forward to partnering with Grace and FosterEd to ensure education success for young people in New Mexico.*

“When I took over this custody case, Maya was five and ready to have overnight visits with her dad. I represented mom, Alicia\* (19), while dad, Javier\* (22), represented himself.


Alicia and Javier had struggled for years to develop a workable parenting plan. Alicia was resistant to overnights, but she acknowledged that Maya has a great relationship with her dad. I explained to Alicia that the court would consider what was best for the child, even if it was hard for mom, and that it would be better to work with Javier to develop a plan they were both comfortable with rather than leave it in the hands of the court. Working with both parents, we developed a visitation plan that allowed the child to spend longer stretches of time with dad, including overnights.

The process allowed Alicia and Javier to talk about their expectations for each other: *being on time, making sure Maya's needs are met, and being flexible with each other's schedules*. The new schedule is less stressful for everyone and Maya is happy she has plenty of time with both her parents.”

“A couple of months ago, a young man walked into our office. I noticed right away that he was distressed, worried and scared. He refused to give me any contact information. While talking with him, I realized that we had spoken on the phone before. He had been sent to another state to live with a relative, but wasn't doing well in the new school. He wanted to come back to New Mexico and continue with his schooling. I asked Matthew Bernstein, one of our Pegasus attorneys, to speak with the youth. *He was able to establish that the youth just wanted to enroll in school.*



Matthew provided the youth with information regarding his rights to enroll in school under the McKinney-Vento Act and referred him to the **APS Title I Homeless Project**.

As the youth was leaving Pegasus, I attempted to gather his contact information again. This time when he turned to look at me, he had a smile on his face and the fear and distress he felt earlier seemed to have melted away.”

"I attended a hearing on an interesting and complicated case immediately after joining the Pegasus team this year. Jessica\* (15) and Cheri\* (13) lived with their verbally abusive mother who did not allow them to contact their deceased



father's family. Jessica ran to her paternal grandparents' home and contacted Pegasus for help when her mother sent Cheri to a "therapeutic" boarding school.

Staff attorney Grace Spulak helped the grandparents file for Kinship Guardianship. Because Jessica had told Grace of her concern for her little sister, Grace convinced the judge to order visits for the girls. Meanwhile, the judge granted the Petition for Guardianship. In a fit of anger, their mother removed Cheri from her school leaving her with all of her belongings at their grandparents' house, saying they could keep her. Cheri later disclosed that the "therapeutic" boarding school used physical abuse and restraint. *Jessica and Cheri are now living happily with their grandparents and are grateful to be reunited.*"

"Recently we worked with a Native American family in a very rural part of the state — *they had to drive a long distance to our first meeting*. They made the trip because the student, Nelson\*, who had a Traumatic Brain Injury (TBI), was not getting the services he needed. Rather than providing the supports the student needed as a result of this TBI and learning disabilities, the school was threatening to call law enforcement. By the time we met with the family, their dilemma was 1) to access public education, Nelson risked getting in trouble with the police because he had a disability that impacted his behavior; or 2) to protect Nelson from criminal charges (*which required keeping him home*) the family risked truancy charges.



The family was stuck. Together we worked to understand the situation at the school *and* the needs of the student, helping the family advocate for a solution that made sense. Nelson

was able to get evaluations and services so that he could be successful both vocationally and academically without risking getting in trouble with the law."

"I represented Shirley\* in her case to be appointed Kinship Guardian of her four-year old grandson, Jason\*. Jason's mother and father have a long history of substance

abuse and incarceration. Shirley's ex-husband had been appointed legal guardian of Jason's half-sister. After giving birth to Jason, mother appeared to be putting her life in order, but eventually fell back into substance abuse. Jason witnessed his father brutally beating his mother: hitting, kicking, choking her, and threatening her life. Mother filed for an order of protection but when both parents tested positive for drugs, the court placed Jason in his grandfather's custody. Since grandfather was already taking care of Andres' sister, Shirley agreed to take him.

I helped Shirley intervene in the on-going case. A court-appointed guardian ad litem recommended that the guardianship be granted. *Shirley was finally able to relax, knowing that Andres was safe and would never be exposed to his parents' sad, violent, and chaotic lifestyle again."*
