Thank you for standing with us, and with them.

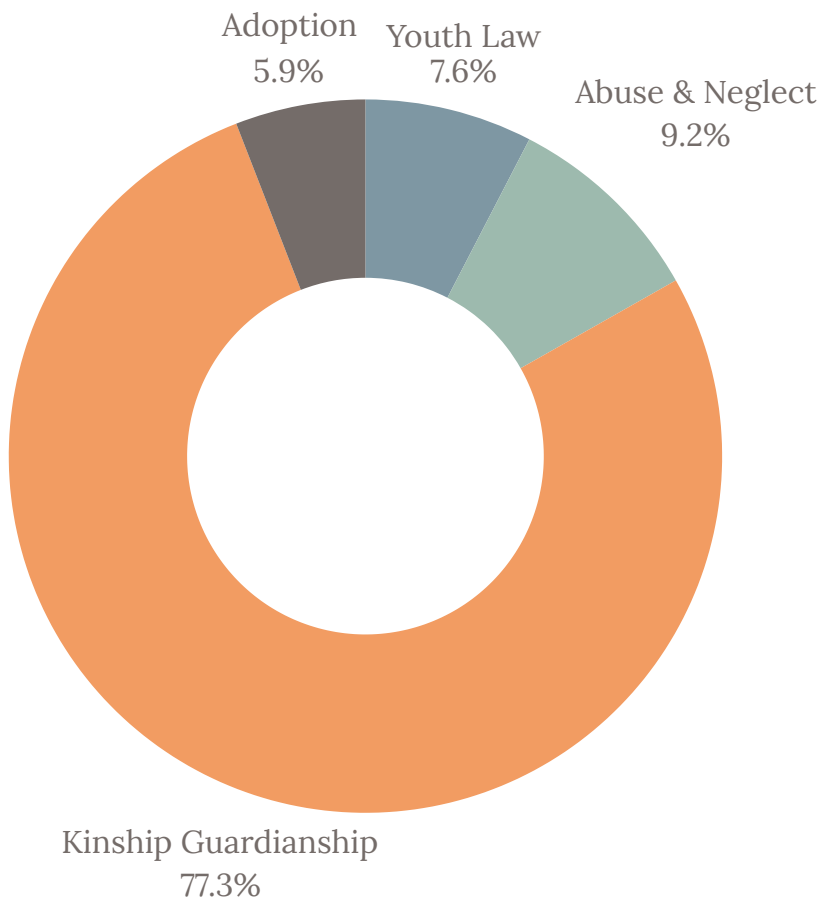

This year we made several programming expansions designed to meet shifting community needs. From adding adoption services and legal services for undocumented youth, to taking on challenging abuse and neglect cases, this year is one for the record books. KINSHIP GUARDIANSHIP

Our largest program is Kinship Guardianship, which supports children whose parents are unable or unwilling to provide them proper care. Kinship caregivers are relatives or other kin who have stepped up to parent a child in need. Children placed in kinship care are shown to experience better health outcomes compared to those in traditional foster care, as the stability of remaining with their extended family positively impacts their mental and behavioral health. Comparable services from a private attorney begin with a \$5,000 retainer, an unattainable cost for Pegasus clients. Pegasus offers Kinship Guardianship services, including full representation, at no cost to our clients.

KINSHIP GUARDIANSHIP LEA & MATEO

Lea lives in northern New Mexico. Lea's niece and her niece's son, Mateo, lived with her when Mateo was a baby. Mateo and his mother moved to New York where they lived until Mateo's mother passed away in a terrible house fire. Mateo's documents and belongings were destroyed, and he began bouncing around his extended family's homes in New York. Mateo's father didn't want to care for him, and Lea knew Mateo needed a permanent home. Lea began pursuing Kinship Guardianship through a private attorney, but after several years, little progress was made. Mateo continued to be moved around family homes from Florida to New York and Lea became increasingly concerned Mateo would be taken into state foster care. A friend recommended Pegasus, and Lea reached out. Pegasus took Lea's case and helped Lea obtain a Kinship Guardianship Order. Mateo has been living with Lea for three years. Mateo is enjoying life in New Mexico, doing well in high school, and playing football and baseball as well as bowling.



Pegasus has been beyond amazing. I am so grateful for everything you have done for me. You led me step by step, got me all the information I needed, and gave me updates as soon as you had them. You held my hand the whole way, calmed me down, and helped me finally resolve my nephew's guardianship. I can't be more appreciative of what Pegasus has done for me and my nephew. I love Pegasus!

YOUTH LAW PROGRAM

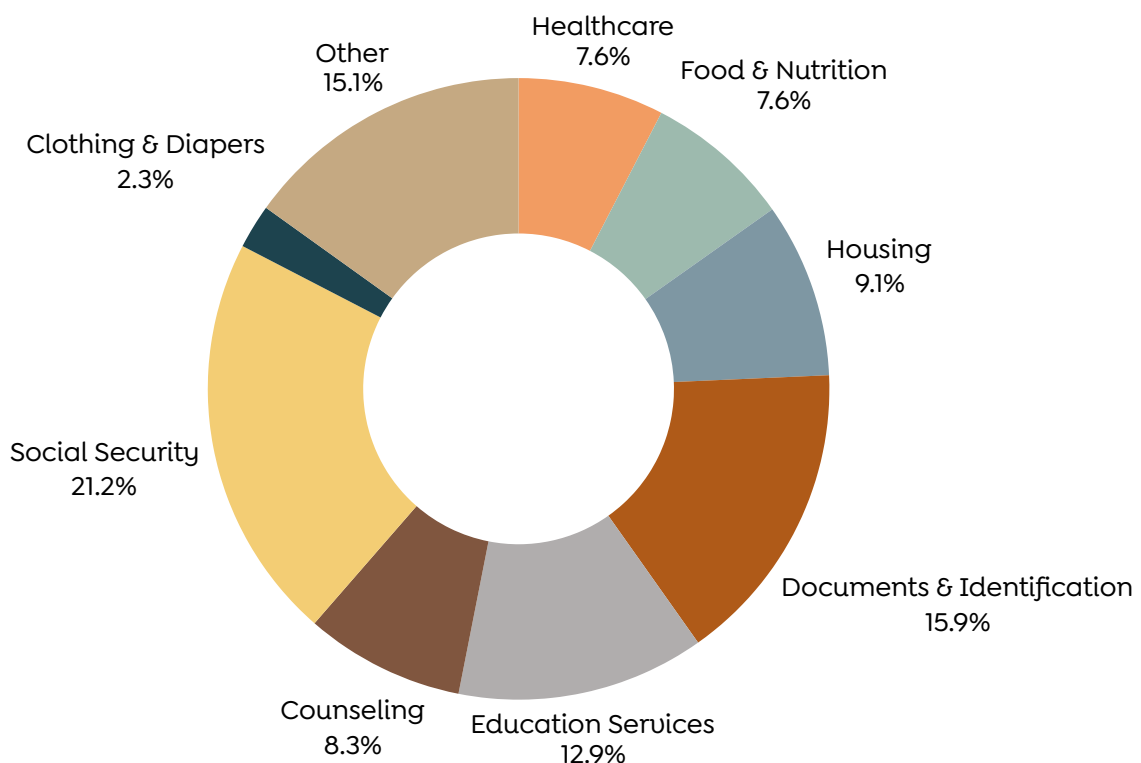
