## PROGRAM HIGHLIGHTS INCLUDE:

1. We directly impacted 668 children and 476 families through direct legal representation; indirectly impacting over 3,500 individuals through statewide outreach, education, policy advocacy.
2. Pegasus' model is unique in New Mexico; we cover ground that few national organizations do. We focus on individual representation and broader policy goals that have significant impact on the lives of children and youth.
3. This year we expanded our representation to the Pueblo of Isleta. Four Pegasus attorneys were admitted to practice in the Pueblo of Isleta Tribal Court.

**Mariel Willow, received her B.A. in Sociology from the University of New Mexico in 2010, and her J.D. from the Tulane University School of Law in 2014. Prior to joining Pegasus in May of 2017, Mariel served as a Staff Attorney for DNA-People's Legal Services in Farmington, and an Assistant District Attorney with the Second Judicial District Attorney's Office in Albuquerque.**

As a Staff Attorney at Pegasus, I get a glimpse into lives of children and family members in our community dealing with the most difficult of issues. They are often bogged down in the “system” and overwhelmed by their experiences. I have the privilege of empowering caregivers by providing a legal avenue for accessing healthcare, education, and other decision-making powers of a parent.

Often times our clients are raising children as their own for years before they have the legal ability to make health care and other decisions about their children. I love my work at Pegasus! My favorite thing about working at Pegasus is handing a client a piece of paper which says they can make all decisions about their child. Providing my clients with a remedy if they have been denied the legal right to take care of their children, is a most basic right which I am proud to protect.

# SPOTLIGHT: EDUCATION LAW

Access to a high quality education is a crucial predictor of the success of young people. Unfortunately, educational opportunity is not equal for all students. Only 24% of New Mexico's third graders are proficient in reading. Students with disabilities are almost twice as likely to receive an out of school suspension than students without disabilities, and are less likely to receive high quality instruction. Young people of color face a host of disproportionate school outcomes when compared to their white peers, including the elevated threat of violence from law enforcement. Food insecurity, a lack of stable homes, and the increasing call for more law enforcement in schools compound academic challenges.

For more than 15 years, Pegasus has protected and defended the rights of New Mexico's students to a free and appropriate public education. In 2017, Pegasus provided legal advice, referrals to high quality services, and direct representation to more than 100 families through our education programs. Pegasus's Education Justice Project continues to collaborate with stakeholders in Sandoval County to connect young people who touch the juvenile justice system with education advocacy. Pegasus also partnered with United Way of Santa Fe County and the Cradle to Career Policy Institute on a survey of school discipline practices among early childhood providers in New Mexico. Every day, Pegasus provides essential education services to enrich the social, emotional, and academic health of New Mexico's young people.



# CHILDREN'S RIGHTS ARE HUMAN RIGHTS

Children have rights, however, those rights are meaningless unless they are defended and honored. Pegasus was founded on the premise of promoting and protecting the rights of children. To be empowered, children need more than just the protection of well-meaning adults – they need a voice in the critical decisions that will decide their future.

Children's Law Advocates have made strides toward actualized children's rights. However, there is still more work to do.

**“Good after noon my name is Alyssa. Congratulations – We made it, class of 2018. A lot of us are so focused on our past, like how did we get here today? What makes you, you? Each of us in this room has a story to tell. Believe it or not, being dealt a rough hand is a gift. It is a gift you should cherish. This gift is unique and only few survive. We are survivors.**

It took me 12 years in the foster care system, nine different high schools, and over 30 different homes to get here today. I never gave up, even when I got pregnant with my wonderful son; I kept going despite the odds against me. Some of us grew up without parents. Some of us will get jobs before college. Some of us will get married young. Some of us graduated at 18 and others at 23. My point is, everything in life happens according to our time. You may look at your friends and some may seem

to be ahead or behind you, but they are not. Each of us has our own journey, so be patient. We will all become something great; like doctors, firefighters, or even the president.

I myself, have many career ambitions and have worn many hats; as of now the one I am most proud of is being a published author of poetry and I would like to share one of my pieces with you, that helped me come to peace with myself.

With crashing waves in this roaring sea  
I'm at ease

Harlena Reed worked with children in both the juvenile justice and abuse and neglect systems in Detroit and Albuquerque as a clinical therapist prior to her legal career. A Detroit native, Ms. Reed is passionate about advocating for the rights of marginalized youth. In addition to her law license, she maintains a clinical social work license.

When I say I represent youth throughout New Mexico, some people say *"Oh you are so good. Teenagers are hard and I couldn't work with them."* I see young people quite differently. When given accurate information, young people are capable of making good choices for their lives. We should never underestimate the incredible strength, wisdom and resiliency of young people. They simply need advocates to support them along the way.

Pegasus continues to offer presentations to teen and young parents throughout New Mexico about child custody related matters. This year, Pegasus

rolled out a webinar of the presentation, expanding our reach and allowing for more opportunities for young people to learn about their rights. Even more exciting is a new tool we have access to as a result of the generosity of Roybal-Mack & Cordova, P.C. Pegasus is now able to provide young parents 25 and under with the ability to complete their Petitions to Establish Parentage, Custody, Time-Sharing and Child Support online at no cost for completing the documents.

*Pegasus also continues to educate homeless youth on their legal rights.*

Meyghan McCrea, graduated with honors from both the National University of Singapore, and from Columbia School of Law. Prior to working for Pegasus, Meyghan worked as an attorney with the Administration for Children’s Services in New York City, and as a corporate attorney, where she was involved in child welfare litigation on a pro bono basis.

Pegasus represents children in foster care in the 2nd and 7th judicial districts. In working on behalf of these clients, I’ve gained new appreciation for the institutional knowledge Pegasus has cultivated and the community relationships it continues to develop and strengthen. Children in the foster care system face not only the trauma and powerlessness of being separated from their families, but often ancillary legal issues related to education, immigration, housing or obtaining appropriate and timely

medical care. Pegasus represents clients holistically, attending educational meetings, communicating with doctors, visiting foster homes and most importantly, listening to our clients, and communicating their concerns before a legal system in which they are often overlooked.

When I joined Pegasus earlier this year, I didn’t appreciate how significant a charge it is to represent children in all aspects of life in which an attorney

might be helpful. It’s both overwhelming and incredibly freeing. I love that in a single day, I can address bed bug issues with uncooperative landlords, counsel a client on the prospects of an emancipation from foster care, obtain support for another client’s educational needs in school, attend a delinquency proceeding for another client, and witness another exit from the fosterhood system and return home to the parents that love her.

This wide-ranging advocacy wouldn’t be possible without extensive collaboration among Pegasus attorneys, social workers and other staff, as well as our clients’ family members, educators, medical providers and members of the larger legal community. I’m grateful for the community of subject-matter experts willing to consult on a host of legal and non-legal issues and grateful that few issues are outside the scope of our representation of one of New Mexico’s most vulnerable populations.
